Under the Data Protection Act 1998, there are restrictions placed on data processors (PNBIL) regarding the transfer of data outside the EU. Information may be used for credit search. I/we understand that the bank may validate name, address and other personnel information supplied by me/us during the process against appropriate third party databases. By accepting these terms and conditions I/we consent to such checks being made. In performing these checks personal information provided by me/us may be disclosed to a registered Credit Reference Agency which may keep a record of that information. I/We understand that Bank may make periodic searches with credit reference agencies and fraud prevention agencies to manage my/our accounts with Bank. Bank will record details at the credit reference agencies of my/our agreements with Bank, the payments I/we make under it and any default or failure to keep to its terms. These records will be shared with other organisations and used by Bank and them to make decisions about credit related services, trace debtors, prevent money laundering and fraud. The credit reference agencies may use this information for statistical analysis. All information provided by me/us will be treated securely and strictly in accordance with the "Data Protection act1998". The Bank will disclose the information which Bank holds if bank is allowed by law, if I give permission/authority to the bank, if it is in bank's interest or if there is a public duty to do so. I have the right to request the data held about me. The Bank's compliance officer will answer any question I may have.
